## **RoHS/REACH Policy**

## **RoHS Compliance**

RoHS Directive 2002/95/EC, 2015/863/EU and subsequent amendments. In order to be RoHS compliant, the substances restricted by the EU Directives must not be contained in a finished product above the threshold limits that are stated below. Unless the restrictive substance is subject of an exemption contained in the RoHS Directive.

Cadmium and its compounds	100 ppm (0.01 weight %)
Mercury and its compounds	1000 ppm (0.1 weight %)
Hexavalent chromium and its compounds	1000 ppm (0.1 weight %)
Lead and its compounds	1000 ppm (0.1 weight %)
Polybrominated biphenyls (PBB)	1000 ppm (0.1 weight %)
Polybrominated diphenyl ethers (PBDE)	1000 ppm (0.1 weight %)
Bis(2-Ethylhexyl) phthalate (DEHP	1000 ppm (0.1 weight %)
Benzyl butyl phthalate (BBP)	1000 ppm (0.1 weight %)
Dibutyl phthalate (DBP)	1000 ppm (0.1 weight %)
Diisobutyl phthalate (DIBP)	1000 ppm (0.1 weight %)

## **REACH Compliance**

In 2007, the European Union Regulation (EC) 1907/2006 concerning the Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH) was first released. This Regulation establishes specific duties and obligations for companies in the European Union (EU) that manufacture or import substances on their own, in preparations, or in articles.

Under the structure of the REACH Regulation, Amplicon is a supplier of articles. We do not manufacture or supply substances or preparations and our articles do not involve the intentional release of any substances.

Amplicon monitor the substances of very high concern (SVHCs) in all of the products we supply and we endeavour to ensure that all of our products are fully compliant with the REACH legislation.
