

REACH Declaration of Conformity

According to the REACH regulation (EU) No. 1907/2006

Categorization

Tosibox is a downstream user according to article 3 no. 13 of the REACH regulation and therefore not obliged to register its products. Downstream users must guarantee that they are using only registered substances.

Basis for the conformity

Tosibox is aware of the European Reach regulation (Regulation (EC) No 1907/2006 of the European Parliament and of the Council of December 18th, 2006 concerning the Registration, Evaluation, Authorization and Restriction of Chemicals and later corrigendum to it.

According to article 31 (1) of REACH-regulation the supplier of a substance or a mixture shall provide a safety data sheet where a substance or a mixture meets the criteria in accordance with Regulation (EC) No 1272/2008 and Directive 1907/2006/EC Annex II, XIII or Article 59 (1).

Furthermore article 33 of the regulation obliges the supplier of a product which includes a substance of the "candidate list" in a concentration > 0,1 % (w/w) to inform its consumers with at minimum the name of the substance. Therefore, Tosibox controls on a regular basis whether its suppliers fulfil their obligations under the REACH regulation regarding Tosibox products.

Tosibox hereby declares based on the information provided by its suppliers that its products comply with the requirements of the REACH regulation. In case that the substances mentioned in the most recent list of substances of very high concern (published by the European Chemicals Agency (ECHA), Link: <u>http://echa.europa.eu/web/quest/candidate-list-table</u>) are contained in Tosibox's final products in concentrations above 0,1 % (w/w) Tosibox disclose them in its Safety Data Sheets.
