MELSEC iQ-R SIL2 Application Guide

SAFETY PRECAUTIONS

(Read these precautions before using this product.)

Before using MELSEC iQ-R series programmable controllers, please read the manuals for the product and the relevant manuals introduced in those manuals carefully, and pay full attention to safety to handle the product correctly. In this manual, the safety precautions are classified into two levels: " WARNING" and " CAUTION".

WARNING

Indicates that incorrect handling may cause hazardous conditions, resulting in death or severe injury.

A CAUTION

Indicates that incorrect handling may cause hazardous conditions, resulting in minor or moderate injury or property damage.

Under some circumstances, failure to observe the precautions given under " CAUTION" may lead to serious consequences.

Observe the precautions of both levels because they are important for personal and system safety.

Make sure that the end users read this manual and then keep the manual in a safe place for future reference.

[Design Precautions]

WARNING

- When the programmable controller compliant with IEC 61508 SIL2 detects a fault in the external power supply or itself, it turns off all outputs in the safety system. Configure an external circuit to ensure that the power source of a hazard is shut off by turning off the outputs. Failure to do so may result in an accident.
- Configure short current protection circuits for safety relays and protection circuits, such as a fuse and breaker, external to the programmable controller.
- When a load current exceeding the rated current or an overcurrent caused by a load short-circuit flows, modules operating in SIL2 mode detect an error and turn off all outputs. Note that if the overcurrent state continues for a long time, it may cause smoke and fire. To prevent this, configure an external safety circuit, such as a fuse.
- When changing data and operating status, and modifying program of the running programmable controller from an external device such as a personal computer connected to the SIL2 Process CPU, configure an interlock circuit in the program or external to the programmable controller to ensure that the entire system always operates safely. In addition, before performing online operations, determine corrective actions to be taken between the external device and SIL2 Process CPU in case of a communication failure due to poor contact of cables.
- Do not use any "use prohibited" signals of modules as an I/O signal since they are used by the system. Do not write any data to the "use prohibited" areas in the buffer memory of modules. For the "use prohibited" signals, refer to the user's manual for each module. Do not turn on or off these signals on a program since normal operations cannot be guaranteed. Doing so may cause malfunction of the programmable controller system.
- When a module operating in SIL2 mode detects an error in a safety communication path, it turns off outputs. However, the program does not automatically turn off outputs. Create a program that turns off outputs when an error is detected in a safety communication path. If safety communications are restored with outputs on, connected devices may suddenly operate, resulting in an accident.
- Create an interlock circuit which uses reset buttons so that the system does not restart automatically after executing safety functions and turning off outputs.

[Design Precautions]

WARNING

- In the case of a communication failure in the network, the status of the error station will be as follows:
 - (1) Inputs from remote stations are not refreshed.
 - (2) All outputs from remote stations are turned off.
 - Check the communication status information and configure an interlock circuit in the program to ensure that the entire system will operate safely. Failure to do so may result in an accident due to an incorrect output or malfunction.
- Outputs may remain on or off due to a failure of an output module operating in SIL2 mode. Configure an external circuit for monitoring output signals that could cause a serious accident.

[Precautions for using redundant function modules]

 The optical transmitter and receiver of the redundant function module use laser diodes (class 1 in accordance with IEC 60825-1/JIS C6802). Do not look directly at a laser beam. Doing so may harm your eyes.

[Design Precautions]

ACAUTION

- Do not install the control lines or communication cables together with the main circuit lines or power cables. Failure to do so may result in malfunction due to noise. Keep a distance of 100mm or more between those cables.
- When selecting external devices to be connected to modules that operate in SIL2 mode, consider the maximum inrush current described in the user's manual for each module. Exceeding the maximum inrush current may cause malfunction or failure of the module.

[Installation Precautions]

WARNING

• Shut off the external power supply (all phases) used in the system before mounting or removing the module. Failure to do so may result in electric shock or cause the module to fail or malfunction.

[Installation Precautions]

ACAUTION

- Use the programmable controller in an environment that meets the general specifications in the MELSEC iQ-R Module Configuration Manual. Failure to do so may result in electric shock, fire, malfunction, or damage to or deterioration of the product.
- To mount a module with no module fixing hook, place the concave part(s) located at the bottom onto the guide(s) of the base unit, push in the module, and fix it with screw(s). Incorrect interconnection may cause malfunction, failure, or drop of the module.
- When using the programmable controller in an environment of frequent vibrations, fix the module with a screw.
- Tighten the screws within the specified torque range. Undertightening can cause drop of the screw, short circuit, or malfunction. Overtightening can damage the screw and/or module, resulting in drop, short circuit, or malfunction.
- Do not directly touch any conductive parts and electronic components of the module, SD memory card, extended SRAM cassette, or connector. Doing so can cause malfunction or failure of the module.
- Securely connect the cable connectors. Poor contact may cause malfunction.

[Wiring Precautions]

! WARNING

- Shut off the external power supply (all phases) used in the system before installation and wiring.
 Failure to do so may result in electric shock or cause the module to fail or malfunction.
- After installation and wiring, attach a blank cover module (RG60) to each empty slot and an included extension connector protective cover to the unused extension cable connector before powering on the system for operation. Failure to do so may result in electric shock.

[Wiring Precautions]

CAUTION

- Individually ground the FG and LG terminals of the programmable controller with a ground resistance of 100 ohms or less. Failure to do so may result in electric shock or malfunction.
- Use applicable solderless terminals and tighten them within the specified torque range. If any spade solderless terminal is used, it may be disconnected when the terminal screw comes loose, resulting in failure.
- Check the rated voltage and signal layout before wiring to the module, and connect the cables correctly. Connecting a power supply with a different voltage rating or incorrect wiring may cause fire or failure.
- Tighten the terminal screws or connector screws within the specified torque range. Undertightening
 can cause drop of the screw, short circuit, fire, or malfunction. Overtightening can damage the screw
 and/or module, resulting in drop, short circuit, fire, or malfunction.
- Prevent foreign matter such as dust or wire chips from entering the module. Such foreign matter can cause a fire, failure, or malfunction.
- A protective film is attached to the top of the module to prevent foreign matter, such as wire chips, from entering the module during wiring. Do not remove the film during wiring. Remove it for heat dissipation before system operation.
- Place the cables in a duct or clamp them. If not, dangling cables may swing or inadvertently be pulled, resulting in malfunction or damage to modules or cables. In addition, the weight of the cables may put stress on modules in an environment of strong vibrations and shocks. Do not clamp the extension cables with the jacket stripped. Doing so may change the characteristics of the cables, resulting in malfunction.
- When disconnecting the cable from the module, do not pull the cable by the cable part. For the cable with connector, hold the connector part of the cable. For the cable connected to the terminal block, loosen the terminal screw. Pulling the cable connected to the module may result in malfunction or damage to the module or cable.

[Wiring Precautions]

ACAUTION

- Do not install the control lines or communication cables together with the main circuit lines or power cables. Failure to do so may result in malfunction due to noise. Keep a distance of 100mm or more between those cables.
- When an overcurrent caused by a failure of an external device or a module flows for a long time, it may cause smoke and fire. To prevent this, configure an external safety circuit, such as a fuse.
- Programmable controllers must be installed in control panels. Connect the main power supply to the power supply module in the control panel through a relay terminal block. Wiring and replacement of a power supply module must be performed by qualified maintenance personnel with knowledge of protection against electric shock. For wiring, refer to the MELSEC iQ-R Module Configuration Manual.
- For Ethernet cables to be used in the system, select the ones that meet the specifications in the MELSEC iQ-R Ethernet/CC-Link IE User's Manual (Startup). If not, normal data transmission is not guaranteed.

[Precautions for using redundant function modules]

 For tracking cables to be used in the system, select the ones that meet the specifications in the MELSEC iQ-R CPU Module User's Manual (Startup). If not, normal data transmission is not guaranteed.

[Startup and Maintenance Precautions]

WARNING

- Do not touch any terminal while power is on. Doing so will cause electric shock or malfunction.
- Correctly connect the battery connector. Do not charge, disassemble, heat, short-circuit, solder, or throw the battery into the fire. Also, do not expose it to liquid or strong shock. Doing so will cause the battery to produce heat, explode, ignite, or leak, resulting in injury and fire.
- Shut off the external power supply (all phases) used in the system before cleaning the module or retightening the terminal screws, connector screws, or module fixing screws. Failure to do so may result in electric shock. Tighten the screws within the specified torque range. Undertightening terminal screws or connector screws can cause drop of the screws or connectors, short circuit, fire, or malfunction. Overtightening can damage the screws or modules, resulting in drop of the screws or connectors, short circuit, fire, or malfunction. Undertightening module fixing screws can cause drop of the screws or modules. Overtightening can damage the screws or modules, resulting in drop of them.

[Startup and Maintenance Precautions]

ACAUTION

- When performing online operations to the running SIL2 Process CPU such as program modification, device test, and operating status change (for example, from RUN to STOP) of the running programmable controller from an external device such as a personal computer connected, read relevant manuals carefully and ensure the safety before operation. The operations must be performed by qualified operators following the operating procedure that is predetermined at the design stage. Modifying a program while the SIL2 Process CPU is running (the online change) may cause corruption of the program depending on operating conditions. Fully understand the precautions described in the GX Works3 Operating Manual before operation.
- Do not disassemble or modify the modules. Doing so may cause failure, malfunction, injury, or a fire.
 The warranty does not cover the products modified or repaired by anyone other than Mitsubishi Electric.
- Use any radio communication device such as a cellular phone or PHS (Personal Handy-phone System) more than 25cm away in all directions from the programmable controller. Failure to do so may cause malfunction.
- Shut off the external power supply (all phases) used in the system before mounting or removing the module. Failure to do so may cause the module to fail or malfunction.
- After the first use of the product, do not perform each of the following operations more than 50 times (IEC 61131-2/JIS B 3502 compliant).

Exceeding the limit may cause malfunction.

- Mounting/removing the module to/from the base unit
- Inserting/removing the extended SRAM cassette to/from the CPU module
- Mounting/removing the terminal block to/from the module
- Do not drop or apply shock to the battery to be installed in the module. Doing so may damage the battery, causing the battery fluid to leak inside the battery. If the battery is dropped or any shock is applied to it, dispose of it without using.
- Before handling the module, touch a conducting object such as a grounded metal to discharge the static electricity from the human body. Failure to do so may cause the module to fail or malfunction.
- Since module cases are made of resin, do not drop or apply strong shock to a module. Doing so may damage the module.
- Shut off the external power supply (all phases) used in the system before mounting or removing the module. Failure to do so may cause the module to fail or malfunction.

[Disposal Precautions]

ACAUTION

- When disposing of this product, treat it as industrial waste.
- When disposing of batteries, separate them from other wastes according to the local regulations. For details on battery regulations in EU member states, refer to the MELSEC iQ-R Module Configuration Manual.

[Transportation Precautions]

ACAUTION

- When transporting lithium batteries, follow the transportation regulations. For details on the regulated models, refer to the MELSEC iQ-R Module Configuration Manual.
- The halogens (such as fluorine, chlorine, bromine, and iodine), which are contained in a fumigant used for disinfection and pest control of wood packaging materials, may cause failure of the product. New standby system	A system that has switched to standby system from control system after system switching

Standby system	A backup system in a redundant system

HOW TO USE THIS MANUAL

This manual describes points to be aware of when an application system compliant with the IEC 61508 SIL2 is configured using the SIL2 Process CPU and modules support the SIL2 mode.

It is user's responsibility to obtain a safety approval for the entire system.

1 OVERVIEW

1.1 Overview of IEC 61508 SIL2 Compliant Programmable Controller

The SIL2 Process CPU, SIL2 function module, and modules that are set to SIL2 mode are the programmable controllers that obtained safety approval (IEC 61508:2010 SIL2 and IEC 61511:2016 SIL2). The customer can use the programmable controllers for configuring a system that satisfies SIL2 of IEC 61508 and IEC 61511.

Safety control and standard control programs can be simultaneously executed with the SIL2 Process CPU. In addition, in a system using the SIL2 Process CPU, both safety and standard communications can be performed on the same network. The IEC 61508 SIL2 compliant programmable controller provides the following safety functions:

- The safety control for turning off safety outputs is executed with a customer-created program to shut off the power of the equipment that causes danger.
- If the programmable controller system cannot maintain a safe state due to a failure, safety outputs are turned off by the failsafe processing to prevent the safety functions from being inoperable.

Redundant system configurations are available to provide the availability of the programmable controller. In a redundant system, if one system fails, the other system takes over and continues the control whenever possible. If the systems cannot be switched, the fail-safe operation described above is performed.


1.2 Risk Assessment and Risk Reduction


When using the SIL2 compliant programmable controller, perform risk assessment on target equipment and select appropriate SIL, as well as reduce the risk conforming to ISO 12100:2010, IEC 61508:2010, and IEC 61511:2016. This section describes the risk assessment and risk reduction.

Risk assessment

The risk assessment is to clarify potential hazards in a device and assess the degree of the hazards.

The following shows the overview of the risk assessment and risk reduction procedures. For details, refer to ISO 12100:2010, IEC 61508:2010, and IEC 61511:2016.

Risk reduction

As a result of the risk assessment, when the device is judged as unsafe, always perform the risk reduction by adding safety measures.

The measures for the risk reduction are standardized in ISO 12100:2010 as described below.

Item		Description


If ensuring the safety of devices by a single safe measure, combine and execute the multiple risk reduction measures until the devices are safe, according to the procedures above.

1.3 Safety Level

This section describes the overview of SIL which is an index showing the safety level.

SIL and target failure measure (PFDavg/PFH)

SIL is standardized by IEC 61508:2010 as an index showing the safety level. Use the following risk graph to select a SIL.



Definition of symbols:

Symbol	Definition	
—, а	No safety requirements	
b	Not sufficient with a single safety-related system.	
1, 2, 3, 4	Safety integrity level Each number stands for SIL1, SIL2, SIL3 and SIL4.	

Probability of risk event occurrence	Definition
Frequent	The probability of unwanted event occurrence is relatively high and repeatedly occurs.
Moderate	The probability of unwanted event occurrence is relatively low and infrequently occurs.
Infrequent	The probability of unwanted event occurrence is extremely low and unlikely occurs.

To achieve the selected SIL, a safety system shall be configured according to the requirements for each SIL of IEC 61508:2010 and IEC 61511:2016. For example, values of PFDavg (target failure measure for low demand mode of operation*1) and PFH (target failure measure for high demand mode or continuous mode of operation*1) indicating failure rates when safety functions are nullified are specified according to SIL as the following table.


2 SYSTEM CONFIGURATION

2.1 System Using SIL2 Process CPU

Use the SIL2 Process CPU in combination with the SIL2 function module. Use this module also with the redundant function module as a pair to configure a redundant system.

Mount the modules on the slots from the CPU slot to slot number 1 in the order of the SIL2 Process CPU, SIL2 function module, and redundant function module.

Mount I/O modules and intelligent function modules set to SIL2 mode with the intelligent device station (remote head module) on CC-Link IE Field Network.





A redundant configuration of network lines is available.

Connect the master station to the remote head modules of the control system and do the same for the standby system. With a redundant configuration of network lines, control is taken over by the standby system if an error occurs on the network of the control system.







- (2) Connect the positive sides of electromagnetic contactors to Y00 to Y0F (output) terminals, and connect the negative sides of electromagnetic contactors to 0V terminals.



For double wiring, perform wiring on a terminal with the same terminal number in both Main and Sub.

2.2 System Start-up


The safety standards conformance approval must be obtained for the customer with entire system. The system inspection is conducted for the entire system including safety components and programs.

Sample programs are shown in this manual. However, the safety standards approval is not obtained.

And all work for configuration of a system using the SIL2 Process CPU (such as design, installation, operation, and maintenance) has to be handled by qualified personnel with knowledge of safety standards, safety devices, and SIL2 compliant programmable controller.

Start-up procedure

For start-up of a system using the SIL2 Process CPU, the procedure for the project of the SIL2 Process CPU and for the project of the remote head module are available. For the settings of each module, refer to the manual for the module used.



Prerequisite for application program

Basic programming

Configure a program for realizing safety functions with attention to the following points.

- Program so that a device is started only when the safe state can be checked at the time the start switch is pressed.
- · Program so that a device is stopped if the safe state is not checked.
- Program so that a device is started at the fall (on → off) of the signal of the start switch. This can prevent a device from accidentally starting at the switch failure (such as contact welding and spring damage).
- To inhibit restart without manual operation after safety functions were activated and outputs were turned off, create an interlock program which uses a reset button for restart.



Creating programs for realizing the safety functions

A program for safety functions is classified as a safety program. A safety program file is distinct from program files for standard programs that describe standard control.

For safety programs, use only safety devices, safety labels, standard/safety shared labels, instructions for safety measure, and safety function blocks, and safety functions.

Configure I/O data of a program for realizing safety functions using safety data. Determine the safety/non-safety of I/O data as follows.

The data in the safety data transfer device to be exchanged in safety communications between the SIL2 Process CPU and modules set to the SIL2 mode on CC-Link IE Field Network is safety data.

■Standard/safety shared label


The standard/safety shared label data are non-safety data. When using the standard/safety shared labels in a safety program, create the program so that the device operates only when safe state is secured. For example, if there are safety devices or safety labels to check safe state of input data from a connected safety device, combine the safety devices and safety labels to form an AND circuit.

Detecting errors in CC-Link IE Field Network

Errors occurred in CC-Link IE Field Network can be detected using safety refresh communication status. Create a program using safety refresh communication status, which turns off safety outputs when an error is detected.

■Safety refresh communication status

The following table lists the names and numbers of special register areas for checking safety refresh communication status of each safety connection. If multiple CC-Link IE Field Network master/local modules are connected to the base unit, the number of the special register area varies according to the number of modules connected. The safety connection number is the one displayed as "No." on the detailed setting window of the safety communication in the CC-Link IE Field Network master/local module.



In the following example, the safety refresh communication status of the safety connection number 1 is checked with SA\SD1008.0 and an output is performed to the safety connection number 1.

If a CC-Link IE Field Network error is detected, the special register areas for the safety station interlock status shown in the following table turn on. Create a program using safety station interlock status, which turns off safety outputs when an error is detected. For restarting communications on CC-Link IE Field Network, the special register areas for the safety station interlock release requests listed in the following table need to be turned on. Create a program that turns on the safety station interlock release requests by a manual operation such as pressing the reset button.





Safety I/O hold

By setting the safety I/O hold time, the time to detect safety communication timeout can be delayed and thus the output value can be held after systems are switched. While the safety I/O is held, the special register areas for safety I/O hold status listed in the following list turn on.

3 PRECAUTIONS

3.1 Precautions for Developing Safety Requirements for Applications

Develop the safety requirements for applications based on the safety requirements specifications and architecture of the system considered by the customer. Include the following items in the safety requirements for applications.

- · Requirements for each safety function
- Restrictions related to hardware and software when the SIL2 Process CPU and modules that support the SIL2 mode are
 used
- · Requirements described in the safety plan created by the customer

3.2 Precautions for Designing Applications

Safety response time

The safety response time is a time taken from when a safety input turns off to when a safety output turns off through the SIL2 Process CPU.

For calculation of the response time of a system to be configured, refer to the following description.

Page 97 Calculation Method of Safety Response Time

Calculation of the target failure measure (PFDavg/PFH)

The systems using the SIL2 Process CPU have obtained the safety approval (IEC 61511:2016 SIL2, IEC 61508:2010 SIL2). The target failure measure (PFDavg/PFH) is a target value of reliability for each SIL level defined in IEC 61508:2010. When a system is configured using SIL2 Process CPUs, one SIL2 application shall configure safety paths which include safety input devices through to safety output devices.

Calculate the PFDavg/PFH for each SIL2 application using the following formula. If a safety path goes through modules set to SIL2 mode multiple times, add PFDavg/PFH values as many times as the safety path goes through those modules. PFDavg/PFH of A) + (PFDavg/PFH of B) × α^{*5} + (PFDavg/PFH of C) × β^{*5*6} + (PFDavg/PFH of D) + (PFDavg/PFH of E)

- *1 When performing safety communications between SIL2 Process CPUs on a safety path, add PFDavg/PFH of the SIL2 Process CPU (paired with the SIL2 function module) performing safety communications on the safety path. Add no PFDavg/PFH of the SIL2 Process CPU (paired with the SIL2 function module) not performing safety communications on the safety path, even though it is on the same network.
- *2 Use PFDavg/PFH of the module set to SIL2 mode used.
- *3 For PFDavg and PFH, refer to the manuals for the safety components used.
- *4 When a SIL2 application includes multiple safety input devices and safety output devices, add all PFDavg/PFH values of these devices and the modules set to SIL2 mode to which they are connected.
- *5 When multiple inputs and outputs of a module set to SIL2 mode are used in a SIL2 application, multiply PFDavg/PFH of the module by the input points and output points.
- *6 Add this value only when using the RY40PT5B.
- *7 When using a temperature input system in a system using the SIL2 Process CPU, add PFDavg/PFH values of signal converters used.

Output value when an error is detected

When an error is detected in a system using the SIL2 Process CPU, the safety digital output turns off and safety analog output becomes 0V and 0mA.

Use of the monitor data of the engineering tool

Do not use the monitor data displayed in the engineering tool for operations related to the safety. (For example, do not start a device or reset the stop state based on the monitor data of the engineering tool.)

3.3 Precautions for Programming

Restrictions related to application program development

Application programs have to be developed by qualified personnel with knowledge of safety standards, safety devices, and SIL2 compliant programmable controller.

When developing programs according to this manual, manage the version of the manual and always use the latest version.

Version management of engineering tool project files

Enter the created date and author at the beginning of a program using the statement function of the engineering tool. When modifying a program, manage the revision history. To manage the revision history, enter information (what changes are made when and by whom) at the modified location using the statement function.



Also manage the project data written to the SIL2 Process CPU by storing them to the hard disk of a personal computer or CDs

User authentication

Define the user who handles the project and the access level and register the user information required for logon in the project and SIL2 Process CPU. For the user authentication function, refer to the following.

3.4 Precautions for Safety Functions Maintenance

Periodic inspection

Perform periodic inspections for ensuring the components such as the emergency stop switch and safety sensors are not faulty.

Perform diagnostics on the connected input devices and output devices as well as on the programmable controller to test the safety functions.

Safety operation mode while in operation

Set the safety operation mode of the SIL2 Process CPU to safety mode in actual operation. Switch the safety operation mode on the engineering tool window as follows: [Online] \Rightarrow [Safety PLC Operation] \Rightarrow [Safety Operation Mode Switch]. For details on how to switch the safety operation mode, refer to the following.

Safety data identify check for SIL2 Process CPU

Periodically check programs or parameters of the SIL2 Process CPU for unauthorized alteration, using the safety data identify check. When changing the safety operation mode to SAFETY MODE after writing safety programs and safety parameters to the SIL2 Process CPU, refer to information on the safety data identify check of the SIL2 Process CPU using the engineering tool and record the information separately.

- Periodically refer to the information on the safety data identify check to ensure that no unauthorized alterations take place.
- If an unauthorized alternation is found, stop operation. Restore the proper project using the backup project file.

For the safety data identify check, refer to the following.

Protecting data

The SIL2 Process CPU and project files of the engineering tool are protected by passwords required for user authentication. Manage the registered password properly and do not leak the password except authorized person to prevent the unauthorized access. For the user authentication function, refer to the following.

4 PROGRAM EXAMPLES

This chapter describes program examples of the system using the SIL2 Process CPU.

4.1 I/O Module with Diagnostic Functions

With the safety input device, this safety program stops the devices connected to the safety output devices. This program controls the start and stop of devices by turning on or off the main contact of the electromagnetic contactor which starts and stops of a device at the safety output device contact.

Connect a safety input device and safety output devices to the I/O modules with diagnostic functions that operates in SIL2 mode.


The SIL2 Process CPU turns on/off the safety output devices with program.

When the I/O modules with diagnostic functions detect an error with the diagnostics function, outputs to the safety output devices turn off independent of the program. In this case, regardless of the program, the outputs remain off until the error clear request is performed for a minor error, and until the I/O modules with diagnostic functions are reset for a moderate error. Configure the program so that the following functions can be achieved.

- **1.** After ensuring safety (the input from the safety input device is on), the operator shall press the reset switch first. Pressing the start switch turns on the safety output device.
- 2. When a safety output device is welded, input the safety output device (normally closed contact) to the input module with diagnostic functions to prevent starting, and check for welding.
- **3.** To avoid undesired operation of the reset switch and start switch at welding or short-circuit, set the reset switch and start switch so that they are activated only when turned on and off.
- **4.** Turn off the output to the safety output device when the input from the safety input device is turned off after the operation is started or when an error is detected in safety communications. Even when an error is detected in safety communications, the output is maintained within the time set in "Safety I/O Hold Time" of "CPU Parameter".


Configure the system with the redundant master station as shown below.

- *1 Connect a safety input device that has two normally closed contacts with direct opening mechanism between the input terminals and test pulse terminals.
- *2 Connect each normally closed contact of the safety output devices between the input terminal and test pulse terminal.





- a. Mitsubishi Electric Company ("MELCO") warrants that for a period of eighteen (18) months after date of delivery from the point of manufacture or one year from date of Customer's purchase, whichever is less, Mitsubishi MELSEC Safety programmable logic controllers (the "Products") will be free from defects in material and workmanship.
- b. At MELCO's option, for those Products MELCO determines are not as warranted, MELCO shall either repair or replace them or issue a credit or return the purchase price paid for them.
- c. For this warranty to apply:
